Gleim CPA Review 2010 Academic Site License Terms and Conditions

Professors and accounting faculty at colleges and universities (the Licensee) can obtain a free CPA Academic Site License from Gleim Publications, Inc. (Gleim) according to the following provisions:

1. Gleim will provide access to a download of the network version *CPA Test Prep Software* for installation in the Licensee's computer lab for student and faculty use. Students can purchase/download the software at a discounted price to use at home so that study sessions and performance tracking data can be transferred between home and school. Students should not have the ability to log into the network and use the Test Prep Software from home.

2. Upon request, Gleim will provide one set of the *CPA Review* books to be placed on reserve in the department office or in the library. Licensee may also request copies of the *CPA Review: A System for Success* booklet to distribute to students (limit 90 booklets per request).

3. Students may purchase the Gleim CPA Review System (books, Test Prep software, audio CDs, and Gleim Online) at the special discounted prices on page two. Student orders under the Site License must be placed directly through Gleim. Professors may not order discounted materials for their students. Bookstores may not purchase CPA Review materials at the Academic Site License prices.

4. Each student will provide a student email address for verification when they order. If students do not have student email addresses, the licensee must provide a roster of students' first and last names for verification. Alumni do not qualify for discounts.

To enroll in the complimentary site license, contact your Professor Relations Coordinator for access to the electronic agreement form. Upon receipt and processing, Gleim will provide Licensee with access to a download of the network version *CPA Test Prep Software*.

Gleim will grant Licensee and each of its students the nontransferable right to use these materials for a term of one year (January 1, 2010 – December 31, 2010). The license may be renewed annually thereafter.
